SOCIETY OF CANADIAN ORNITHOLOGISTS REPORT ON MEMBERSHIP – AS OF 31 DECEMBER 2012

This report gives the picture of SCO membership as of December 31, 2012. Following the recommendation by the Auditor, the Membership Report now follows SCO's fiscal year, January 1 - December 31. In this report, we will compare the situation between 31 December 2011 and 31 December 2012.

The membership levels at the end of 2012 are fairly consistent with those of the previous year. The number of members was 343 and there has been very little change in the distribution over the membership categories (Table 1).

Of the 343 paid up members, include 56 new members and members who rejoined the society after being previously archived.

At the end of December 2012 there were 70 members who had not yet paid for 2012 (Table 2). The number of non-renewals always goes down in the first weeks of the year, after final notices are sent.

In April 2012, the names of members who did not pay for 2011 were archived. A pattern is emerging which shows that there is a decrease in the number of renewals every second year (Table 3).

Table 4 shows that 32.7% of the current members joined before 2005. The overall retention rate of the SCO-SOC is a very respectable 81.8%.

The renewal pattern of members has remained fairly consistent with half of them preferring to renew every year (Table 5). 45.4% of the regular members renewed for more than one year while about 65.8% of the students did so.

A breakdown of the membership by category is shown in Table 6. The number of Sustaining memberships is now 9 from a high of 18 in 2007. The SCO gives a charity receipt of \$25 for Sustaining memberships and of \$250 for Life membership. Two people became Life members in 2012, bringing the number of Life members to 24.

The geographical breakdown of SCO-SOC membership is shown in Table 7. With the addition of our first member from Nunavut, the SCO-SOC now has a member in every province and territory. Overall, the membership distribution across Canada has remained the same as last year. Membership abroad (most of these members are expat Canadians) has dropped substantially from that of recent years.
