# 2. President's report Hannon

The state of the SCO is very good. Our membership is healthy, finances are good, the website is doing well, and all committees are active, including our new conservation committee. Furthermore, we have excellent winners of our student and professional awards.

# 3. Treasurer's Report (Hannon)

2007 revenue came from memberships, donations (gifts), SCO share of profits from the NAOC, and interest. Expenditures were roughly similar to 2007. Thus we recognized a net earnings of \$10 221.

Expenditures were roughly the same in both years – increase was in gifts, sponsorships, etc.

The society is in good financial shape, with total assets of \$47 992

# 4. Membership Secretary's Report (Bird)

The membership report follows the fiscal year from January 1 to December 31. At the end of 2007 the society had 410 members, an increase from 393 in 2006. This includes 57 new members and 13 who rejoined out of 84 that were archived (did not pay in 2006). Generally, there is an increase in local membership after a conference, however these members are difficult to retain. It is also difficult to retain students, many of whom join to apply for awards. Memberships from academia and private consultants increased, but members from the federal government decreased.

Multi-year renewals (46% in 2006) are excellent: increases retention; saves on banking and postal costs, and makes it easier for treasurer/membership secretary.

There are 20 sustaining members. Student membership are steadily increasing (16 free ones given out as awards), there are 4 lifetime members at \$500 (\$250 tax receipt).

SCO is well-represented geographically (local increases after conferences); 36 members abroad. The website with downloadable registration form is useful, and we have email addresses for 394 out of 410 members.

**Robert DeCaire** of the Department of Biology, University of Western Ontario, won the **James L. Baillie Award** for research on "Do brood parasites alter host offspring sex ratios due to their larger size?"

**Roslyn Dakin** of the Department of Biology, Queen's University, won the **Fred Cooke Award** for research on "The signal content of the peacock's train: testing the role of nanostructure."

**Andrea Norris** of the Centre for Applied Conservation Research at University of British Columbia won the **Junco Technologies Award** for research on "The long-term perspectives on resource pulses: How are cavity-nester populations regulated following a mountain pine beetle outbreak?"

# 7. Nominating Committee/Elections Bird

Bird thanked John Chardine, Nicola Koper, Joe Nocera, Andrea Pomeroy, and Ryan Norris who all agreed to serve a second term.

There were 3 vacancies for councilors and VP/President Elect in 2008. 81 ballots were received. Congratulations to Erica Nol who was elected as VP/president-elect and to Debbie Badzinski, Russ Dawson, and Paul Martin who were elected as councilors.

Bird also thanked Therésè Beaudet for her help.

In 2009 Erica NoI (incoming Vice President) will form a nominating committee of 3 to seek nominations for council.

### 8. ACE-ECO Journal Committee/Editors Report Francis

Francis presented the journal statistics (5 issues published, of 46 articles, 54% rejection rate, 72 day average turnaround time).

A new publication agreement was reached with resilience alliance, who has agreed to accept financial liability. They agreed to limit increases in page charges for the next 5 years. BSC and SCO retain content control (E.g. select editors etc.).

In the last year there has been discussion around focus and scope and niche. The journal committee discussed the issue with editors and have clarified and refined the focus and scope, clarified uncertainties around journal policy, resulting in a clearly defined niche.

A question was asked of who is indexing journal.

Francis replied that getting the journal indexed is slow (usually 3-4 years) but that progress moving forward, and that resilience alliance is working toward that.

The "official bylaws" (as opposed to the working documents) were discussed and edited at the council meeting. Hannon will finalize revisions, circulate them to be voted on by council, and circulate them to members for a vote at next meeting.

11. Website Nocera

Joe Nocera replaced Ken Otter as the website coordinator in January.

Nocera decided to consider a facelift for the website, and so tracked usage over 2 months and presented the statistics (see website report)

The majority of users view the webpage in English/US, however, French users comprised a significant number of visitors (10-15%). Most visitors use Internet Explorer or Firefox (with windows), and there were surprisingly few Mac users. A few users still access the site with dial up.

Thus, changes to the website need to optimize for dial up and internet explorer.

Of the 331 visits tracked, most people used 1.5 pages and stayed less than 10 sec – many people used it to get ACE-ECO. One goal of the redesign will be to get people to stay on the site and explore while allowing people to access the specific pages they are looking for quickly.

The back issues of *Picoides* were scanned for the webpage, however the scanned versions are high resolution. Nocera will reduce the file sizes to speed up download time.

# 12. Conservation Committee, Advocacy, Cat Resolution Nocera/Nol

The conservation committee was struck after the 2007 meeeting. The committee includes: Tony Gaston, Erica Nol, and Joe Nocera.

This year they received 2 tasks:

- comments on incidental take regulations through OC
- request from an SCO member want to take an issue on the cat/bird issue

Options for the role of the Conservation Committee: Generate resolutions Produce position statements (white paper) Write letters of support Inform other groups of relevant issues (e.g. OC)

Upcoming: action on above further refine role update on activities in *Picoides* 

The issue of resolutions sparked discussion among the committee, council, and discussion at the AGM included below:

Generally, members were opposed to making resolutions and taking on an advocacy role.

Resolutions could be a conflict for government workers to comment on government regulations and policies.

The AOU, given its small size has opted to stay out of advocacy- rather to provide science to advocacy groups – e.g. national Audubon, WWF, TNC, have more clout, financial resources, and more members than AOU. Advocacy is partly the role of the Ornithological Council, through which as a member, we have a lot of potential through the OC and as individuals.

The role of the SCO is not of advocacy, but of science.
On issues related to advocacy it was recommended that we:
Redirect individuals to an advocacy group.
Provide sound scientific information to advocacy groups/individuals.

The role of the conservation committee might be:

To encourage science in Canada on Canadian bird issues. For example, the committee might highlight conservation issues that are under-researched through articles in *Picoides*, to present articles on particular issues, and/or to point out to members uncertainties and gaps in science on conservation issues. Furthermore, the committee could bring national issues that might impact birds in Canada to the attention of the membership. Finally the committee was urged to be as proactive as possible, and not limit themselves to being reactive to issues arising.

**ACTION**: The conservation committee will compose a mandate, circulate it to the membership and add it to the working documents.

**ACTION:** The conservation committee will speak to the member about the cat issue and will report the outcome to the membership.
